PARTICIPANT AGREEMENT, RELEASE, AND ASSUMPTION OF RISK for the year of 2021

In consideration of the services of Hidden Hollow and Knowlton Swim Clubs, LLC., Linvilla Orchards, inc., Paul and Margaret Linvill Associates, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "HHKSC"), I hereby agree to release, indemnify, and discharge HHKSC, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my membership at the swim club entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
The risks include, among other things: muscular strains and sprains; cardiac complications; accidental drowning; and slips and falls getting in and out of the pool and around the pool facility. Furthermore, HHKSC employees have difficult jobs to perform. They seek safety, but they are not infallible. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless HHKSC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of HHKSC's equipment or facilities, **including any such claims which allege negligent acts or omissions of HHKSC.**
4. Should HHKSC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against HHKSC, I agree to do so solely in the state of Pennsylvania, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
7. I have read and agree to abide by the Swim Club Rules. A Copy of the rules are on Member Letter and on the website www.linvilla.com.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against HHKSC on the basis of any claim from which I have released them herein.

SUPPLEMENTAL WAIVER OF LIABILITY PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

“COVID AGREEMENT”

In consideration of my desire to use and/or participate in the services of Knowlton and Hidden Hollow Swim Clubs, LLC, Linvilla Orchards, Inc., Paul and Margaret Linvill Associates, their agents’ owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as “HHKSC”), and the activities, events, recreation, programs, facilities, and equipment owned, made available and/or present at HHKSC;

I, on behalf of myself, my children, parents, dependents, heirs, assigns, personal representative(s) and estate, understand and expressly agree to the following:

In recognition of the ongoing COVID-19 a/k/a Coronavirus, which is extremely contagious and is believed to spread mainly from person to person, and which has been declared a worldwide pandemic by the World Health Organization (hereinafter the “Covid virus”), and acknowledging the risk of transmission and/or infection and/or contact with the Covid virus;

(1) I acknowledge and agree that HHKSC has made no assurances or warranties or representations whatsoever as to the safety, or sanitation of HHKSC’s activities, recreation, events, facilities, equipment, members, pools, grounds, or services and acknowledge inherent risks of personal injury, harm, illness and death is associated with the Covid virus and/or other infectious diseases or illnesses or pathogens, or variations or mutations thereof.;

(2) I, hereby agree to release, forever discharge, hold harmless, indemnify and covenant not to sue or bring any claim for damages or harm of any kind, on, HHKSC, with respect to any and all injuries, illnesses, risks, death, medical expenses, damage or harm of whatsoever kind or nature suffered by me, including but not limited to exposure and/or infection and/or contact with the Covid virus and/or other known and unknown illnesses or pathogens. In addition, I waive my right to pursue any remedy, claim or lawsuit whatsoever as to HHKSC in the event I, my children or my family are harmed or suffer any loss, injury, illness, death or damage pertaining to the Covid virus and/or other illnesses in any way connected to my/our use of HHKSC.;

(3) I agree that my participation and use of HHKSC, and that of my children, relations, and guests, is voluntary. I have considered the risks of my/our use of HHKSC, and expressly agree and promise to accept and assume all risks, known and unknown, connected with use of HHKSC and any and all HHKSC related activities or offerings. Should HHKSC or anyone acting on their behalf be required to incur attorney’s fees and costs to enforce this Agreement, I agree to hold them harmless for all such fees and costs.;

(4) I acknowledge and agree that if any portion of this Agreement is found void or unenforceable, the remaining portions shall remain in full force and effect, with this Agreement being interpreted under the laws of the Commonwealth of Pennsylvania.;

(5) I agree to follow to the best of my ability the rules, preventive guidelines and requests of HHKSC, in general and pertaining to use of HHKSC as it pertains to the Covid virus, and will undertake my best efforts to ensure that my children, family and guests comply with such requests.;

These rules have been made to protect your health and safety. Please review them before coming to the pool.

All Members and Guests are required to follow current PA State Guidelines for masks and social distancing.

COVID-19 WARNING

- The danger of exposure to the coronavirus that causes COVID-19 exists.
- By entering the pool, you take responsibility for your own protection and for disinfecting your hands and anything you touch.
- Do not use the pool if you have a cough, fever or other symptoms of illness.
- Maintain at least 6 feet between you and other people who are not part of your household.
- Wear a face covering when you are not in the pool.

We are requesting that you follow the CDC policy, and kindly ask if you are displaying symptoms of sickness (such as the common cold, any flu symptoms, or general symptoms of illness) to please stay home and wait until you are symptom-free before visiting both Hidden Hollow & Knowlton Swim Clubs.

Participate at your own risk. All Members and Guests agree to abide by all rules. The following rules supersede the standard club rules. All club rules are still in effect.

SOCIAL DISTANCING Parents / Caregivers (not lifeguards) are responsible for ensuring children social distance during the time at the clubs; both in and out of the pool. Parents should have a discussion with children before their first visit to ensure they understand the importance of respecting other members' boundaries. Members from the same household are not expected to be practicing social distancing with each other. Maintain at least 6 feet between you and other members who are not part of your household.

MASK All members age 2 and older will be required to wear a mask to enter the facility. Masks will not be required in the pool or while social distancing. Dispose all masks and gloves in the proper receptacles.

DISINFECTING Both Hidden Hollow & Knowlton Swim Club will be disinfected throughout the day.

BATH HOUSE Showers will be closed. Please use bathrooms only when necessary. It would be preferred for members to wear bathing suits to and from the clubs. Bath house rules are subject to CDC Guidelines.

PLASTIC PANTS Children who are not toilet trained must wear pool-appropriate diapers in the baby pools with plastic pants over the diapers – **no exceptions!** Children in diapers may not use the 25 or 50-meter pools at HHSC. Plastic pants will be available at each pool for a nominal fee. Huggies Swimmies also require plastic pants. This rule will be strictly enforced.

POOL USE No one is permitted in the pool unless a lifeguard is on duty. Do not use the pool if you have a cough, fever or other symptoms of illness.

LOST AND FOUND ITEMS will be thrown away at the end of each day. If you think you left something at the pool, please call us or stop back by and pick it up.

PARTICIPANT & COVID AGREEMENTS All members and guests will use the facility at their own risk. All members and their guests must sign a Participant Agreement and a COVID Agreement releasing HHSC, KSC, and Linvilla Orchards from liability.
